

RESOLUTION NO. 2009-03

A RESOLUTION of the City of Bainbridge Island, Washington, amending and clarifying the City's miscellaneous fee schedule as it relates to fees for the usage of the city dock, linear moorage system, and boat ramp in Waterfront Park, as last amended by Resolution No. 99-19.

WHEREAS, the City established fees for use of the City's dock and linear moorage in Eagle Harbor by Resolution No. 93-36, Resolution No. 97-34, and Resolution No. 99-19; and

WHEREAS, the City wishes to defray maintenance costs of the Waterfront Park facilities by amending the fee structure for the Boat Dock and Linear Moorage and adding additional fees for use of the boat ramp and parking lot;

WHEREAS, a new fee for the first three hours of mooring at the boat dock will be added to the fee schedule, and the boat dock mooring fee for time in excess of three (3) hours will be increased from \$.25 per foot to \$.50 per foot;

WHEREAS, new fees for use of the boat ramp with boat/trailer parking, commercial use of the boat ramp and hand launch with car parking will be added to the City's fee schedule; now therefore,

THE CITY COUNCIL OF THE CITY OF BAINBRIDGE ISLAND, WASHINGTON, DOES RESOLVE AS FOLLOWS:

Section 1. The Boat Dock and Linear Moorage Fee set forth in the "Miscellaneous Fees" section of Resolution No. 92-39 and subsequently amended by Resolution No. 97-34 and Resolution No. 99-198, and the City's fee schedule setting miscellaneous fees charged by the City are amended as follows:

BOAT DOCK MOORING FEE FIRST THREE HOURS	\$.10 per foot for three (3) hours or less
BOAT DOCK MOORING FEE	\$.50 per foot for any time in excess of three (3) consecutive hours in any 24-hour period
LINEAR MOORAGE FEE	\$0.25 per foot for any time in excess of three (3) consecutive hours in any 24-hour period

Section 2. The City's fee schedule setting miscellaneous fees charged by the City are amended to add the following:


**BOAT RAMP WITH BOAT/TRAILER
PARKING** **\$8 per day; \$80 per year**

**BOAT RAMP – COMMERCIAL (GROUP)
USE** **\$20 per day; \$200 per year**

HAND LAUNCH WITH CAR PARKING **\$5 per day**


